NCHSAA 2014 BASEBALL PITCHING POSITIONS WIND UP SET

LEGAL POSITIONS:

WIND UP:....

THE NON-PIVOT FOOT MUST BE ON OR BEHIND A LINE DRAWN THRU THE FRONT EDGE OF THE PICTHERS PLATE.

THE PIVOT FOOT MUST BE IN CONTACT WITH OR IN FRONT AND UP AGAINST THE FRONT EDGE OF THE PITCHERS PLATE.

BOTH FEET MAY BE IN FRONT AND IN CONTACT (WITH THE HEELS UP AGAINST THE PITCHERS PLATE).

SET POSITION:..

THE <u>PIVOT FOOT MUST BE IN CONTACT WITH AND PARRALLEL TO THE PITCHERS</u> <u>PLATE.</u> IT CAN BE ON TOP OR IN FRONT OF AND IN CONTACT WITH THE PLATE. THE PIVOT FOOT SHALL NOT BE AT ANY ANGLE OTHER THAN **PARRALLEL TO THE PITCHERS PLATE AND WITHIN THE 24" WIDTH OF THE PITCHERS PLATE.**

THE NON-PIVOT FOOT MUST BE ENTIRLY <u>IN FRONT OF THE FRONT EDGE OF THE</u> <u>PITCHERS PLATE</u>,

THE NON-PIVOT FOOT IS NOT RESTRICTED TO BE WITHIN THE 24" WIDTH OF THE PITCHERS PLATE .

ANY VIOLATION OF THE PIVOT OR NON-PIVOT FOOT PLACEMENT IN EITHER THE WIND-UP OR SET POSITIONS SHALL BE CALLED AN ILLEGAL PITCH, OR IF RUNNERS ARE ON BASE A BALK. WHEN EITHER ILLEGAL PITCH OR BALK IS CALLED THE BALL IS DEAD. FOR AN ILLEGAL PITCH A BALL IS CALLED ON THE BATTER, IF RUNNERS ARE ON BASE THIS IS A BALK, RUNNERS ADVANCE ONE BASE, NO BALL IS CALLED ON THE BATTER.
